<p>Principal's Update &amp; Staffing for 2020-2021</p>	<p>Ms. Parker will be hosting a parent session “Success on Line at Home” this Tuesday from 6:30 pm-7:15 pm. Presenter is Dr. Ticola Ross from Cano Family Services will be presenting. This will be a virtual parent session. For all parents, 41 parents signed up, presenter’s kids are in CMS, great opportunity for families to get insight into how to make home a good virtual learning environment, helpful in providing strategies and tips for remote learning</p> <p>K-5 Scholars return Nov. 2nd on A/B rotation. As of 10/22, there hasn’t been a change in rotation. Revised calendar for rotation. A - Mon-Tues B - Thurs-Fri Wednesday for elementary is asynchronous day, scholars in remote and in rotation will have the entire day asynchronous, scholars have SEL from 8:30-9. Not allowed to go over an hour Wednesday mornings if instruction is provided after SEL. Teachers can provide small group, new content within that time. EC and EL will have opportunities throughout the day for services and teachers are looking at how to adjust instruction for time frames.</p> <p>As of 10/22/2020, Middle School is still on week rotations.</p> <p>Families in rotation should be receiving back to school information by the end of this week. Ms. Branham will host two parent sessions next week on Wed., Oct. 28th at 6 pm or Thursday Oct. 29th at 9 am. All staff, scholars, visitors must have screener before entering the building. Information on CMS and school website. Scholars will remain in vehicle while series of questions are asked. Ideally the symptom screener is completed prior to getting to campus to expedite the process. Staff will look for green check on phone and/or check roster for completion, after screen temp is checked, student exits car and is escorted to his/her classroom. An adult with child at all times, markers along the hall to indicate 6ft distance.</p> <p>Isolation room and restroom - used for scholars who do not pass the screener/ temp check. Ms. Vaneck will work isolation room. We have nurse extender</p>

	<p>until December to help assess scholars not feeling well in the isolation room. Will call parents for students in isolation room, parent/ guardian expected to pick up. Scholars cannot ride bus back home. Be as honest as possible when answering questions for safety of all in building.</p> <p>Question: How will parents receive access to screener?  Screener will be sent to students through Canvas and/or email, also found on CMS website. Ms. Branham will also push out through Parent Square with a QR Code.</p> <p>Question: What will happen if a student has symptoms?  Nurse in building to assist and complete any additional assessment if needed</p> <p>If student ends up in isolation room, they will not be able to ride bus home.</p> <p>Bus Attestation  <a href="https://www.cms.k12.nc.us/cmsdepartments/transportation/Pages/default.aspx">https://www.cms.k12.nc.us/cmsdepartments/transportation/Pages/default.aspx</a></p> <p>If a scholar is a bus rider, the attestation form in above link is completed once/ week. Blue sheet of paper - mailed to families. Submit on Monday to bus driver\, series of questions based on screening. Parent signs and dates at bottom of form. Scholars will be screened once off the bus. Show green check, designated areas on the bus lot, staff members will escort to the classroom. All scholars will be escorted throughout the building.</p>
