Dear Parent/Guardian:

I hope the school year has started successfully for all of you. As a parent/guardian of a student in **Cochrane Collegiate Academy**, I am writing this letter to let you know that **Cochrane Collegiate Academy** has been designated as a Targeted Support & Improvement Additional Targeted Support (TSI-AT) school by the North Carolina State Board of Education. As stated in ESSA Section 1111(d)(2), North Carolina had to identify schools for targeted support and improvement. TSI-AT schools in North Carolina are those that have a subgroup that is under-performing. The intent of this opportunity is to improve educational outcomes for all students, close achievement gaps, increase equity, and improve the quality of instruction.

As a TSI-AT school, **Cochrane Collegiate Academy** is required to develop a comprehensive plan that specifically addresses how the school will improve student achievement. The plan will also include how our district will support us and monitor the progress of our school. The comprehensive plan will address the following areas:

- Classroom Management
- Standards-aligned Instruction
- Professional Learning Communities (PLCs)
- Instructional Leadership
- Recruitment & Retention of Effective Teachers
- Support for Grade-to-Grade Transitions
- Implementation of a Tiered Instructional System
- Data-Driven Decision Making
- Student Support Services
- Family and Community Engagement

We have set the following goals for **Cochrane Collegiate Academy** this year:

- ***Ensure Mastery-based, standard aligned instruction 100% of the time***
- ***Reduce suspension rates by 10%***
- ***Reduce chronic absenteeism by 10%***
- ***AVID Schoolwide Implementation of Writing, Collaboration, and Reading***
- ***increase overall school academic growth to 70%***
- ***Hispanic Students GLP increased to 35%***
- ***Increase Students enrolled in CTE, Honors, AP, and CCP Offerings by 10%***
- ***iMeck Graduation Rate increase to 100%***

Our students need to experience higher achievement levels, but it will require hard work on the part of staff, students and families. Here are some strategies **Cochrane Collegiate Academy** will be implementing:
