


# Druid Hills Academy Parent Involvement Policy 2020-2021 Dr. Carla G. Mathis

At Druid Hills Academy, a Title 1 school, we want strong parent and community involvement and engagement. Active parental and community involvement greatly affect our students' academic and social/emotional success. This policy represents a living, fluid document designed to be inclusive of parental, community members, and other school stakeholders' input.

1. Parents, community members, and school stakeholders provided input into the development of this policy, which is available to all parents for comments on its contents at parent meetings and social events held. The school placed a parent suggestion box in the main office as a mean to collect parent input. Parents also provide input via email and verbally. The team finalizes the plan after all comments have been reviewed. The team reviews and updates the policy annually.
2. The school administration team holds an Annual Title I meeting within the first 45 days inform parents of the parental requirements under Title I Section 1118. The team encourages parents to participate in their child's education, stay informed of their rights, and become involved at Druid Hills Academy.
3. Parent meetings and workshops occur at various times of the day to accommodate parents' work schedules. Scheduled meetings and events include: School Improvement Team (SIC) Meetings, Drive-by Open House, Drive-by Student Resources and Supplies Pick-up and Information Event, Parent Conferences, Curriculum Week, EOG Parent Information Session, and Parent Drive-in Movie Night. The PTA provides refreshments to help increase parents' attendance at meetings.
4. The Title I team provides parent workshops designed to help parents work with their children to achieve academic and social growth. Funds allocated through Title I funds provides parent workshop materials, facilitators and other necessary expenses to increase parental involvement.
5. The school administration encourages parents to participate in the planning, reviewing, and improvement of the school's Title 1 program at School Improvement Team Meetings (SIT) and placing their input in our Parent Suggestion Box which is available to all parents daily at Druid Hills Academy.

6. Parents and community members may access an electronic copy of the school-wide plan on the school's website and a hard copy upon request from the secretaries in the main office. Parents may submit comments on the plan in writing to the principal's office.
  7. At the present time, Druid is not in school improvement status.

  9. Teachers provide parents with a description and explanation of the curriculum utilized at the school, the forms of academic assessments used to measure student progress and the proficiency levels students are expected to meet. Parents receives the following information:
    - The purpose of Title I and the school's Title I allocation
    - Various other federal and state programs that assist in raising the achievement level of all the students (i.e. IDEA, Title V, Act 135, EAA) and the resources available to the parents and their children due to the additional federal and state funds.
    - Additional programs that help raise the achievement level of the students most academically in need.

The following academic assessments serve as measurements used to determine academic growth and proficiency levels.

    - MAP Testing in Reading and Math, NC Check-in Benchmarks, EOG Assessments, and teacher-made assessments
  10. Parents receive communication in a language they can understand.
  11. The Title I team hosts regular meetings throughout the year to allow parents the opportunity to make suggestions and recommendations relating to the education of students at Druid. All school staff respond to parents' requests and comments within 48 hours.
  12. In the Spring, parents receive the school-parent compact to review and provide input. Parents serving on the School Improvement Team (SIT) takes parents' comments into consideration when revising the school-parent compact.
